NATIONAL EAS TEST COMING SEPT. 28

On September 28, 2016, at 2:20 p.m. ET, the FCC and FEMA will conduct the second nationwide test of the Emergency Alert System. The nationwide test will assess the reliability and effectiveness of the EAS.



The test message, the first using the new EAS FIPS Code 000000 (New National Location Code) and using the modified EAS Event Code 'NPT' (National Periodic Test), will clearly state that the alert is only a test of the EAS.

The results of the nationwide EAS test will be captured and analyzed using the FCC's new EAS Test Reporting System (ETRS). The deadline for filing Form One through the ETRS was August 26, but FCC officials say late filers should still register.

All broadcasters are required to participate, including LPFM stations. An FCC spokesman told Radio World they are willing to work with LPFM's to get them on board. "We recognize LPFM stations' unique limitations, and we are prepared to work one-on-one with them should they need help navigating their way through [the] upload of Form 1 information," the spokesperson said.

Certain "day of test" information will be required on ETRS Form Two on September 28, and additional information regarding your participation in the nationwide test will be due on ETRS Form Three by November 14, 2016.

FCC SHUTTING 11 FIELD OFFICES

The Federal Communication Commission is moving ahead with plans to shut down multiple field offices as part of its "modernization" plan.



Field offices in Anchorage, Buffalo, Detroit, Houston, Kansas City, Mo., Norfolk, VA., Philadelphia, San Diego, San Juan, Puerto Rico, Seattle, and Tampa

will be shut down beginning in January 2017.

In lieu of the shuttered offices and the loss of up to 44 employees, the FCC will create fast response teams designed to respond to interference or other issues within 24 hours. The so-called "Tiger Teams" will be based out of Denver and Columbia, Maryland. 11 other field offices, including Boston and New York will remain open.

The National Association of Broadcasters and the Society of Broadcast Engineers are both concerned the closings will cause an increase in pirate radio activity.

SILBERBERG SELLS WTWK

Steven Silberberg's Radio Broadcast Services, Inc in Colchester is selling Plattsburgh's WTWK (1070 AM) to Aaron and Jessica Ishmael's A&J Radio LLC.



A&J Radio is also buying an FM translator at 96.3 MHz from Silberberg's Montpelier Broadcasting Inc and have applied to move the translator to 103.7 MHz. The total purchase price is reported to be \$140,000.

A&J Radio also operates WZXP-FM (97.9 MHz), licensed to Au Sable, New York, under an agreement with Randy Michaels' Radioactive LLC.
