FCC APPROVES NEW VERMONT EAS PLAN

NATIONWIDE EAS TEST SET FOR SEPT. 27



The FCC and the Federal Emergency Management Agency (FEMA) have announced that this

year's National Test of the Emergency Alert System (EAS) will be held at 2:20 p.m. EDT on Wednesday, September 27. If conditions are not conducive the test will be delayed until the following Wednesday, October 4.

All radio, TV and cable outlets are required to air the test simultaneously and then use the FCC's Electronic Test Reporting System (ETRS) to report the results. Many broadcasters recall the frustrations with registering at ETRS last year. Stations were required to update their ETRS Form 1 by August 28. By midnight on test night stations must submit data on Form 2. A final submission, Form 3, is due on November 13.

ARMY NATIONAL GUARD TO RESUME VAB PARTNERSHIP

The VAB is happy to announce that the Army National Guard will resume their participation in the VAB's NCSA program on radio and television. The start date is tentatively set for November 1. 1100 FILE FM TRANSLATOR APPS

It will be a busy few weeks at the FCC as they sort through the nearly 1100 applications filed by AM stations seeking to construct FM translators.

The latest filing window opened July 26 and closed August 2.

In Vermont, five AM stations applied for translators in the latest filing window. WIKE Newport filed for a translator at 103.1; WKVT-AM in Brattleboro applied for 106.9; WRSA St. Albans filed for 100.3; WSTJ in St. Johnsbury applied for a translator at 104.1; and WTWN in Wells River filed for a translator at 105.1.

In New Hampshire, stations applying for translators include WKDR Berlin for 92.5; WMOU Berlin for 107.9; WXEX Exeter for 107.5; WTSV Claremont for 94.3, WTSL Hanover for 97.5; WZBK Keene filed for 102.3; WEZS Laconia applied for 103.3; WLTN Littleton filed for a translator at 107.5; WBNC North Conway applied for 105.3; and WPNH Plymouth filed for 92.9.

Thanks to Scott Fybush of Northeast Radio Watch for aggregating the translator application information. He reports it should be only a few weeks before the FCC starts taking long-form applications that will generate construction permits.
