Remembering Broadcaster Ann Curran



Broadcaster Ann Curran, 77, passed away unexpectedly in Burlington Saturday, December 24, 2022.

Earning her master's degree in communications from UVM, she began her career in 1975 at the PBS affiliate, Vermont Educational Television (now Vermont Public). Until her retirement, Ann worked in senior leadership positions, including Manager, Marketing and Communications and for the last five years, she was the legislative liaison.

Ann's face was familiar to Vermonters due to her numerous appearances on the network's pledge drives. She often worked with national PBS officials as well as employees of other PBS stations.

in 2009, she was named VAB Broadcaster of the Year and in 2013, the Ann Curran Green Room was created to honor her before she retired later that year.

Q4 Issues/Programs List Deadline Now 1/31



Recognizing that issues have been affecting the Online Public Inspection File system, the FCC extended the deadline for uploading Quarterly Issues Programs list to the public file until January 31.

FCC ETRS Form One Must Be Filed By 2/28



The FCC's Public Safety & Homeland Security Bureau has announced that technical updates to the <u>EAS Test Reporting System ("ETRS")</u> have been completed and the ETRS is open and available to accept filings of Form One by EAS participants. The deadline to file is February 28, 2023.

READ THE FULL ARTICLE

Under FCC Rules, EAS participants must update their information annually via a Form One filing. This is typically done in connection with a nationwide EAS test, but FEMA did not conduct a test in 2022 and hasn't announced a 2023 test. Therefore, ETRS Form One must be filed no later than 2/28/23.
