# VSAC & Engineering Scholarships



In an effort to help employees of Vermont radio and TV stations, the VAB offers a scholarship through VSAC. If you work for a Vermont station and you or your family member are planning to attend or already attending college, apply for the VAB scholarship through VSAC by 2/15/23.

- Up to \$1,250 awarded annually to one recipient chosen by VSAC.
- To be eligible, you must be a family member of an employee of a Vermont radio or TV station.
- Student can be attending any accredited institution of higher learning.
- · Student must be enrolled full time in any degree program.

#### **APPLICATIONS** DUE 2/15/23

**Vermont Association of Broadcasters Scholarship** The intent of this scholarship is to fund an employee or a direct family

#### member of an employee of a Vermont radio or television station.

- Eligibility:
   Be an employee or a direct family member of an employee of a Vermont radio or television station
- · Enroll full time

- Demonstrate school/community involvement/service
   Demonstrate financial need
   Attend an accredited school approved for federal Title IV funding (Pell grants, federal Direct loans)

Required documents: Unified Scholarship Application, FAFSA, one recommendation letter #2 (community service), essay #1 (general essay), and membership information (broadcast relation declaration letter with the full name of the broadcast employee; the full name of the radio or television station where the employee works; and the employee's relationship to you, if applicable).

Amount: Up to \$1,250 awarded annually\*

Selection: Membership information (broadcast relation declaration letter), recommendation letter, essay, and financial need

Estimated applicants: 7

Estimated awards: 1



#### ENGINEERING ACADEMY

Are you are a DJ or MMJ but would like to make the switch to behind the scenes? Are you an Operations Director or PD whose job requires you know more about engineering than you do? Are you an engineer mentoring a student with great potential?

If so, the VAB encourages you to apply for a scholarship to attend ABA Engineering Academy classes in Birmingham, Alabama February 20-24 (radio), April 3-7 (TV) or June 16-20 (radio).

These 5-day classes cover the basics of radio or TV engineering and at the end, students can take an entry level Society of Broadcast Engineers Certification Exam.

The VAB is paying to send the right candidates to these classes either to a) "kickstart" their broadcast engineering education so they can be hired as assistant engineers and eventually take over for retiring engineers or b) give existing staff a working knowlege of how to fix basic engineering issues quickly.

### Remembering WOOL-FM Co-Founder Gary Smith



WOOL-FM Co-Founder Gary Smith passed away at his home, January 16, 2023 at the age of 64.

While Gary was an accomplished guitarist and songwriter, he found his calling outside the spotlight at Fort Apache, a scrappy recording studio that he built into a clubhouse for young musicians and a global force in alternative rock. As a producer and manager, Gary shepherded the careers of some of the era's most influential artists, but his impact transcended the realm of records and contracts. Gary brought people together, cultivating a sense of family that sustained him and the many outsiders, misfits, and dreamers fortunate enough to travel in his orbit.

Leaving the fast-paced city life, Gary relocated Fort Apache from Boston to Bellows Falls, VT, opening the recording studio and a new live performance venue in the former Hotel Windham.

Over the next two decades Gary's local imprint grew. He was a founder of community radio station WOOL-FM, launched a regional events magazine, and opened Popolo, an Italian-inspired farm-to-table restaurant.

When Gary received a cancer diagnosis in September of 2022, his chief concern was how to get the long list of everything he wanted to accomplish done. Gary's vision and integrity, prodigious intelligence, marvelous sense of humor and steadfast care for people and community will continue to inspire the legion of comrades mourning his loss. # FCC Extends Due Date for Children's TV Annual Report and Online Public Files to 2/28



The FCC recently issued a Public Notice extending the deadlines for all filings that were due at the end of January in the FCC's LMS or online public file systems to the new deadline of February 28, 2023.

This includes Children's TV Annual Reports (which were due January 30) and Quarter 4 Issues/Programs lists (which were originally due to be uploaded to station public files January 10, but hadalready been extended to January 31).

This extension until February 28, 2023 was necessitated by widespread technical issues with the LMS and online public file systems.

# FCC ETRS Form One Must Be Filed By 2/28



The FCC's Public Safety & Homeland Security Bureau has announced that technical updates to the <u>EAS Test Reporting</u> System ("ETRS") have been completed and the ETRS is open and available to accept filings of Form One by EAS participants. The deadline to file is February 28, 2023.

READ THE FULL ARTICLE

Under FCC Rules, EAS participants must update their information annually via a Form One filing. This is typically done in connection with a nationwide EAS test, but FEMA did not conduct a test in 2022 and hasn't announced a 2023 test. Therefore, ETRS Form One must be filed no later than 2/28/23.
