

# Keeping AM Radio on the Car Dashboard



In a blog post yesterday, NAB President & CEO Curtis LeGeyt gave a stirring defense of AM radio in cars. As Ford, Tesla, BMW, and Audi remove AM from the dashboard, LeGeyt reminds carmakers of AM's role on "the front lines of history."

AM's prevalence in rural communities and America's largest cities makes it a ubiquitous need. More than 47 million Americans still listen to nearly 4,500 local AM stations. The NAB continues its work with lawmakers and the auto industry to improve AM radio reception and technology.

The post cites former FEMA administrators and the FCC, who both expressed their firm beliefs that AM radio provides a crucial emergency service to Americans when crisis strikes.

LeGeyt says, "With its unique ability to reach a wide geographic area, AM broadcasting offers many Americans struggling with poor, or non-existent, cellular and broadband coverage a chance to stay

connected. The car is often the only source of power and news for many in times of emergency."

### Automakers Response to Sen. Markey Letter



In December, Senator Ed Markey (MA) sent a <u>letter</u> urging automakers to maintain access to free broadcast AM radio, including in electric vehicles, for sake of public safety.

The <u>responses from the automakers</u> are worth reading, but if you don't have time to read all 32 pages, here is a great summary by Dave Arland from the Indiana Association of Broadcasters:

Essentially, the carmakers who have deleted AM radio are telling the Senator that they design "global" platforms and that AM radio is dead elsewhere. Also, the influence of Google's Android Auto operating system, pictured above, is obvious (no AM radio). There's also some artful dodging of the Senator's questions:

"...AM radio service...is provided via digital radio platforms (thus ensuring enhanced audio quality)..." In other words, go find an AM station on their app...not ours.

Tesla was equally careful, pointing to the TuneIn app: "Tesla identified TuneIn as an alternative streaming application to provide Tesla owners with access to their preferred local AM radio stations..."

BMW says find a translator: "BMW offers free digital FM broadcasting through which many radio stations simulcast their AM radio programming..."

Ford admits: "This information is now available through several alternate means..."

Kudos to Chrysler: "To help protect the AM radio band from noise and interference, our company has, for example, used shielded high voltage cables and connectors...."

Cheers for Toyota: "All Toyota and Lexus vehicles currently on sale include AM/FM and HD radio, including Toyota's fully battery electric vehicle..."

Honda keeps AM, likely because they co-developed their electric car with GM.

Hooray for Hyundai: "AM and FM radio are available in all Hyandai vehicles distributed in the United States. We have no plans to discontinue either of these in future vehicles."
