# **Government Advocacy:**

## Federal:

- ★ Following NAB State Leadership Conference in Washington DC in February, VAB held in person meetings with Sen. Leahy, Rep. Welch's staff and a virtual meeting with Senator Sanders' staff.
- ★ Advocated for:
  - Journalism Competition & Preservation Act
  - Local Radio Freedom Act. The antidote to the American Music Fairness Act being considered in House Judiciary.
  - Diversity Tax Certificate Program
  - Safe Advertising Act (Cannabis Legislation)
- ★ VT is one of 25 states in the "Safe Advertising Coalition" investing in D.C. lobbying firm Klein Johnson to get FCC and DOJ protections for Broadcasters who want to advertise Cannabis.

### State:

- ★ Cannabis Marketplace:
  - State legislature gave the Cannabis Control Board autonomous oversight over marketing rules and regulations.
  - Concerning rule about proving 85% of audience is 21+.
  - VAB taking a "let's see how this plays out" approach.
- ★ Sports Betting:
  - At the urging of Governor Scott, DLL and the VAB, the Senate Economic Development Committee took up S.77, an act to legalize sports betting in VT. Concerned VT would adopt the 1-agent NH model with caps on ad spending, the VAB testified with a compelling argument not to limit advertising. The committee called for a commission to do a study this Fall, which the VAB will monitor.
- ★ Silver Alert Program:
  - VAB testified in House Human Services that overuse of the EAS tones will create listener/viewer fatigue and that based on estimates from VT State Police, EAS is not the best way to disseminate information in these cases.

# **Alternative Broadcast Inspection Program:**

★ 2021 was an Alternative Broadcast Inspection Program (ABIP) year. The VAB paid Spectrum Investigative Services \$45,500 to conduct 91 inspections at no cost to any of the stations!

#### **Recruitment Videos:**

- ★ VAB worked with UVM and Champlain College to produce two videos one about how enriching working in radio can be and the other highlighting careers in TV behind-the-scenes. A third video promoting careers in Media Sales is in the works!
- ★ VAB.org/careers is being built and will be launched with a digital marketing campaign to reach Gen Z where they spend the most time.

# **Paid Internship Program:**

- ★ In order to expose young adults to our industry and solve a workforce shortage problem, the VAB subsidized payroll for 5 college students to intern at five stations! Each station got a check for \$1,731 to pay 120 hours @ \$12.55/hour + 15% for payroll taxes.
- ★ Nine more paid internships will be made available this Fall, Spring and Summer. Apply at vab.org

## FCC, EEO & EAS Support:

### FCC/EEO:

- ★ Kept the FCC from increasing broadcasters Regulatory Fees by successfully arguing in 50-state joint comments that the FCC should charge entities utilizing FCC resources (ie broadband) regulatory fees instead of increasing fees for existing payers.
- ★ Offered two Political Broadcasting webinars with a DC law firm and an FCC Panel
- ★ Posted local job openings on VAB.org, providing employers with EEO credit opportunities.

#### EAS:

- ★ Scheduled two State Emergency Communications Committee (SECC) work sessions to update Vermont's EAS Plan.
- ★ Negotiated EAS test schedule with VEM that keeps tests out of Prime and Drive times.
- ★ Represented broadcast radio & TV while VT State Police tested the Amber & Blue Alert Systems.
