#### FCC Approves Final Rules for FM Geotargeting



Federal Communications Commission The Federal Communications Commission has adopted final rules to allow FM boosters to originate programming for three minutes an hour.

READ RADIO WORLD ARTICLE The change will allow stations to deploy the geotargeting system called ZoneCasting. Earlier this year the commissioners began to allow such operations on a temporary, experimental basis. They now have approved the final rules, again unanimously.

When the newly adopted rules become effective, initiating such service on an authorized booster will not require FCC prior approval. Instead, broadcasters only need to notify the FCC, using a form to be developed by the FCC's Media Bureau, of their intention to begin program origination on an authorized booster 15 days before that operation begins.

#### "Engineering On a Budget" Training in May

The VT, NH & ME Association of Broadcasters, in conjunction with various industry experts, will be hosting a one-day series of "engineering on a budget" sessions in the northeast. This will be a full day of "no sales pitches allowed" training, focused on small market broadcasters who must get every watt they can out of every piece of equipment. The date is tentatively set for either Wednesday, May 7th or 14th in North Conway, NH a central location to the three states.

These sessions will consist of 8-9 presentations, each running 40-45 minutes and focused on maintaining older equipment, optimizing performance and getting as much mileage out of it as possible. Topics planned are:

- 1. Studio maintenance and optimization
- 2. Audio over IP the hows and the whys
- 3. Getting the most out of your processor and what to do when it 'just doesn't sound right'
- 4. STLs and wireless IP best practices
- 5. LTE interference mitigation for when the cell company calls
- 6. Care and feeding of the antenna system
- 7. Lightning protection and facility grounding practices
- 8. Transmitter maintenance and cost of ownership/operation
- 9. Speaking manager how to talk about ROI and other acronyms

There is no cost to attend, lunch is included and there will be a hotel block available at preferred rates for folks who need to drive in the night before or stay over the night of or both.

The purpose of letting engineering folks know about this event now is to estimate how many people would attend to determine how large a venue we'll need. ## WFAD-AM in Middlebury Back On The Air!



Previously silent WFAD(AM) 1490 in Middlebury has returned to the air, simulcasting Mud Radio LLC's WMUD(FM) 101.5 in the Rutland market under an LMA with Christian Ministries, which operates The Light Network across Vermont.

Chip Morgan and Maria Slattery saved the station from having its license deleted after WFAD lost its tower lease.

WFAD-AM is back on the air under Special Temporary Authority from the FCC with a reduced power temporary antenna while a new full power site is located.
